

## **Boarding Agreement**

This is a contract between Bailey Doggiewood, LLC dba Lakeside Doggie Lounge or Woodlands Doggie Village (herein called "Kennel") and the pet(s) owner whose signature appears below (herein after called "Owner").

- Kennel agrees to exercise due diligence and reasonable care. Kennel agrees to keep the premises sanitary and properly
  enclosed and to provide services in a reliable, caring, and trustworthy manner.
- Owner acknowledges that it is not possible to protect against all risks to their dog/cat(s) at any time, even with the exercise
  of due care and attention and whether at the kennel or in transport, that these risks include injury, escape, theft, disease,
  and fire.
- Owner specifically represents to Kennel that the pet has not been exposed to rabies or distemper within a thirty-day period
  prior to boarding and that it is in good health and current with all required immunizations. By signing this contract and
  leaving pet(s) with kennel, Owner certifies to the accuracy of all information given about pet.
- Pet(s) must have a statement of current immunizations. Vaccination records must be on veterinarians print out. Dogs:
   DHLPP, Rabies, and Bordetella.
- As we strive to be a flea free facility, if upon admission your pet is found to be carrying fleas or ticks, we will administer a
  flea treatment and bath. A \$35 per pet charge will be applied to the Owner's account.
- All charges incurred by Owner shall be payable upon pick-up of pet. A handling fee of (\$25) will be charged on all returned
  checks. In the event it is necessary to initiate collection proceedings on the account, Owner will be responsible for all
  attorney's fees and costs of collection.
- If pet becomes ill or if the state of the pet's health requires professional attention, the Kennel, in its sole discretion, may
  engage the services of a veterinarian or administer medicine, or a special diet, or give other requisite attention to the pet
  and the expenses will be paid by the owner. Owner will fully reimburse Kennel for any veterinary care.
- If pet dies while boarding at Kennel, the Kennel will immediately attempt to notify Owner via emergency contact information left by owner. The body will be stored at either the Owner's veterinarian or as per Owner's instructions.
- I release the kennel from all liability for injury, damage or loss suffered by me, my pet(s), members of my family or guests and which loss is or may have been caused directly or indirectly by an act or admission of the kennel or by any person or property in the vicinity and during the courses of the kennel providing the services requested and whether resulting from negligence or any cause. I agree to indemnify the kennel and save it harmless from all claims and costs of any nature and kind in respect of any loss caused or contributed to by my dog/cat(s) including any damage to the property of kennel and I assume the sole risk of and the responsibility for same.

If Injury occurs, I authorize kennel staff to obtain medical or surgical treatment for the safety and comfort of my pet and that I will reimburse the kennel for all costs incurred for this treatment. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees. This contract contains the entire agreement between the parties. All terms and conditions shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Kennel for this visit and all subsequent visits.
